("POMEGA"), has received an order worth 54,621,000 USD (Fifty-Four Million Six Hundred Twenty-One Thousand US Dollars) excluding taxes, for the supply and commissioning of a total 303.5 MWh energy storage system. This includes Iğdır DGES (~97 MWh), İzmir Aliağa DGES (~20 MWh), Mardin Artuklu DGES (~40 MWh), and an additional ~145 MWh DGES at various domestic locations as part of our customer Egesa Elektrik İnşaat Enerji Üretim A.Ş.'s Licensed Solar Power Plant with Storage (DGES) projects.
